VERIFIED PETITION FOR WRIT OF MANDATE FOR VIOLATIONS OF THE RALPH M. BROWN ACT

California Government Code §§ 54952.2, 54954.5, 54957, 54960, 54960.1

Petitioner Lori Ann Farrell Harrison ("Petitioner" or "Ms. Farrell Harrison") brings this petition for writ of mandate against Respondents the City of Costa Mesa and City Council of the City of Costa Mesa (collectively "City" or "Respondent") pursuant to, *inter alia*, the Ralph M. Brown Act, Government Code sections 54960, *et seq.* ("the Brown Act"). Respondents violated multiple provisions of the Brown Act when they failed to properly notice and agendize two separate meetings – one on April 15, 2025 and May 6, 2025, as required under Government Code section 54954.5, pertaining to Closed Session item descriptions, regarding a May 6, 2025 Closed Session. Respondents also violated the Brown Act when certain Councilmembers engaged in serial meetings regarding Ms. Farrell Harrison's termination outside of an authorized meeting, in

violation of Government Code section 54952.2(b)(1).

Ms. Farrell Harrison avers as follows.

#### **PARTIES**

- 1. Ms. Farrell Harrison was appointed City Manager for the City of Costa Mesa, California (the "City") on May 7, 2019 by the Costa Mesa City Council. She served as City Manager from July 1, 2019, until her termination on May 6, 2025.
- 2. The City Council is a "local agency" as defined by Government Code section 54951, and a "legislative body" as defined in Government Code section 54952. The City Council is comprised of seven elected City Councilmembers (*i.e.*, the Mayor of Costa Mesa, as well as City Councilmembers from each of the City's six districts). The City is a "local agency" as defined by Government Code section 54951.
- 3. The true names, identities, or capacities, whether individual, corporate, associate or otherwise of Respondents DOES 1 through 10 inclusive, are unknown to Petitioner, who, therefore, sues said Respondents by such fictitious names. When the true names, identities, or capacities of such fictitiously designated Respondents are ascertained, Petitioner will ask leave of this Court to amend the Complaint to insert such names, identities, and capacities together with the proper charging allegations.
- 4. Petitioner is informed and believes, and thereon alleges, that each of the Respondents sued herein as DOES 1 through 10 are responsible and in some manner are liable herein for the wrongful conduct herein alleged, and by such wrongful conduct, proximately caused Petitioner's injuries and damages.

#### JURISDICTION AND VENUE

- 5. The Court has jurisdiction of this matter under the Brown Act and Code of Civil Procedure section 1085.
- 6. Venue is proper in this Court under Code of Civil Procedure section 395 because the City Council and the City of Costa Mesa are located within the County of Orange, California, and the events giving rise to this petition for writ of mandate occurred in Orange County.

#### **BACKGROUND**

- 7. Petitioner joined as the City Manager of the City of Costa Mesa by written agreement dated May 7, 2019.
- 8. On or about Monday, March 28, 2025, Ms. Farrell Harrison notified three members of the City Council, including Councilmember Loren Gameros, about significant challenges with Mayor John Stephens involving potential violations of law and resulting potential liability to the City. The issues of concern identified by Petitioner included, but are not limited to, the Mayor's potential conflicts of interests; quid pro quo activities; violations of state, local, and federal laws and regulations; and gender and racial discrimination toward City employees.

  Ms. Farrell Harrison was informed that efforts would be made to privately encourage the Mayor to voluntarily agree to course corrections to resolve these issues.
- 9. On Monday, April 14, 2025, Petitioner was informed that Councilmember Gameros no longer had an interest in speaking with the Mayor. He instead suggested that Ms. Farrell Harrison consider taking an early retirement.
- 10. Thereafter, at the Tuesday, April 15, 2025, City Council meeting, the Council unanimously approved Councilmember Marr's request, in Open Session, to add an urgent item to the "Closed Session" portion of that meeting to discuss this issue, under "Potential Litigation." Per the official Minutes, Closed Session was thereafter held from 4:03 p.m. to approximately 6:00 p.m. and resumed again at 10:39 p.m.; the minutes reflect that the Mayor left at 10:39 p.m. and did not join the Closed Session. (See **Exhibit A**, City Council Meetings Minutes for April 15, 2025.) The Closed session thereafter ended at 11:42 p.m. (*Ibid.*)
- 11. Ms. Farrell Harrison was informed the following day, on Wednesday, April 16, 2025, that an investigation in response to her verbal report about the Mayor's potentially unlawful conduct was being commenced. Ms. Farrell Harrison was also informed that the City Council decided to agendize a performance review of the City Manager at the next regularly scheduled City Council meeting. Notably, this topic the public employee performance review (of the City Manager) was not on the April 15, 2025 agenda; hence, such a discussion was unlawfully held

during the agendized "Potential Litigation" item. Further, Ms. Farrell Harrison was informed and believes, and thereon alleges, that this was communicated as being a preliminary step – to develop performance metrics – for the performance review that would later take place on schedule at the end of 2025. Later that day, Councilmember Marr and Ms. Farrell Harrison discussed the importance of providing the written report to the City Council, regarding the Mayor's unlawful activity, as directed, before the next regularly scheduled City Council meeting of May 6, 2025.

- 12. On April 29, 2025, as directed by the Council, Ms. Farrell Harrison provided a 14page complaint to six members of the City Council regarding potential unlawful activity by Mayor Stephens titled, "Formal Complaint – Mayoral Potential Conflicts of Interest, Illicit Interference, and Undue Influence in City Operations, Permitting and Contracts." The report was developed by the City Manager and other members of the Executive Team based on their interactions with the Mayor and his requests for inappropriate or unlawful activities.
- 13. On Thursday, May 1, 2025, Ms. Farrell Harrison was interviewed for approximately four (4) hours by the outside investigator hired to conduct the investigation regarding Mayor Stephens's potential illegal conduct, as herein alleged. Said investigator had a copy of Ms. Farrell Harrison's April 29, 2025, complaint/report.
- 14. The following day, on Friday, May 2, 2025, the City Council published a notice and corresponding agenda in advance of the May 6, 2025, meeting. In the Closed Session category, the agenda included the following two items (Nos. 7 and 8):
  - 7. CONFERENCE WITH LEGAL COUNSEL- ANTICIPATION OF LITIGATION -

Pursuant to California Government Code Section 54956.9 (d)(2), Potential Litigation.

8. PUBLIC EMPLOYEE PERFORMANCE EVALUATION Pursuant to California Government Code Section 54957. (b)(1) Title: City Manager

A true and correct copy of the May 6, 2025, Agenda is attached hereto as **Exhibit B**. Item 8 on the Agenda listed only "public employee performance evaluation" and did not state "public employee discipline/dismissal/release." (See Gov. Code §§ 54954.5(e) and 54957(b)(1).)

- 15. Ms. Farrell Harrison had been informed that she should be prepared to identify metrics to measure her performance at the May 6, 2025, City Council Meeting. More specifically, Ms. Farrell Harrison understood that there would be a discussion of performance metrics that day that would serve as the basis for her upcoming calendar year 2025 performance evaluation later in the year, as no performance metrics had ever been provided to her in the six years that she served as the City Manager, although her contract specifically called for it, and she had received two previous outstanding performance evaluations without specific performance metrics being identified.
  - 16. Petitioner alleges the following concerning the events of May 6, 2025.
- At approximately 3:50 p.m., Ms. Farrell Harrison went to the First Floor to a. join the City Council for the opening of the meeting and then adjournment to Closed Session in Council Chambers. The Police Chief, who was already downstairs and was in attendance due to the Police Association tentative agreement, stated to Ms. Farrell Harrison: "They are switching the order of items. Potential Litigation is going first." At approximately 4:00 p.m., Ms. Farrell Harrison and the City Council are in the Council Chambers to open the Closed Session. The City Attorney, Kimberly Barlow, approached Ms. Farrell Harrison before it began and stated that "Potential Litigation is going first." Item 7 on the May 6, 2025 Meeting Agenda ("Potential Litigation") was the second-to-last item on the agenda. Ms. Farrell Harrison was informed and believes that this was to be the follow-up discussion regarding the investigation of the Mayor that had been authorized by the City Council at the previous City Council meeting held on April 15, 2025. Ms. Farrell Harrison asked Ms. Barlow whether she was needed for the discussion. Ms. Barlow answered, "No."
- b. Ms. Farrell Harrison thereafter went to the City Hall First Floor Break Room while she waited to be called in to the Closed Session. At about 4:15 p.m., the president of a local union came to her and said, "I've been looking for you." He stated that he wanted to warn her that she might get fired that evening. He explained that he had spoken to Councilmember Gameros right before the Closed Session, and Gameros told him, "[Y]ou watch, we're going to switch this whole thing around – instead of this being about the Mayor, we are going to make it

about Lori Ann." Ms. Farrell Harrison thanked him for the information and tried to reassure him that everything would be fine.

- Ms. Farrell Harrison waited for approximately 1.5 hours to be called in to c. the Closed Session. She had prepared a 35-page PowerPoint Presentation to share with the City Council highlighting her accomplishments for the past two years (Calendar Years 2023 and 2024). She brought copies of the report with her to the meeting, and it was also loaded onto the projector in the Community Room. Ms. Farrell Harrison was never called into the room to make her presentation. However, she assumed, during her wait, that the Councilmembers were still deliberating on the "Potential Litigation" item (No. 7 on the agenda), which was about her formal complaint against Mayor Stephens, and the ensuing investigation.
- d. At approximately 5:35 p.m., Ms. Barlow came into the Break Room, where Ms. Farrell Harrison was waiting. Ms. Barlow was visibly distraught. Ms. Barlow asked the Assistant City Manager and Deputy City Manager to leave the room. Ms. Barlow told her that there would be a public announcement in a few minutes stating that the City Council had voted to terminate Ms. Farrell Harrison's employment. Ms. Barlow emphasized that she was not there to give legal advice, and expressed her sincere apologies for what had happened. Ms. Farrell Harrison later learned that an outside attorney (not Ms. Barlow) was hired to advise the City Council on the termination.
- The open meeting was convened at approximately 6:00 p.m., per the May 6, 2025, Council Meeting Minutes, which is attached hereto as **Exhibit C**. There was a public announcement of the City Council's decision to terminate Ms. Farrell Harrison by a vote of 4 (yes), 2 (no), and 1 (abstain). The Minutes reflect that Mayor Stephens had attended the Closed Session and that he had abstained from the vote on Ms. Farrell-Harrison's termination.
- f. Ms. Farrell Harrison spoke with the staff of the City Manager's Office and other staff members for a short while and thereafter drove home.
- Ms. Farrell Harrison called the Police Union and the Costa Mesa City Employees Association to apologize for not being able to see the Tentative Agreements that she and staff had negotiated all the way through to final approval by the City Council as these items

were never discussed that evening. Both Union agreements were pushed to the next regularly scheduled City Council meeting, May 20, 2025. Within a couple of hours, the *Los Angeles Times* posted an article on the internet, "Costa Mesa City Council Fires its City Manager." Ms. Farrell Harrison was thereafter bombarded by calls from the media, City employees, former co-workers, colleagues, friends, and family.

- 17. Ms. Farrell Harrison was stunned by these events, as was her staff, who supported her efforts to elevate the discussion about these serious challenges with Mayor Stephens, and required that the behaviors discontinue. How the City moved from trying to solve a serious liability with Mayor Stephens's potentially illegal activity to a public firing of its well-respected, accomplished City Manager has but one answer: the City retaliated against Ms. Farrell Harrison for her protected disclosures.
- 18. On June 5, 2025, Ms. Farrell Harrison, through counsel, sent a demand to the City to cure or correct these multiple violations of the Brown Act. On June 20, 2025, the City rejected all of Ms. Farrell Harrison's contentions and declined to cure or correct the Brown Act violations.

### FIRST CAUSE OF ACTION (Violations of Ralph M. Brown Act, Gov. Code §§ 54957, 54960, 54960.1, et seq.)

- 19. Ms. Farrell Harrison re-alleges and hereby incorporates each and every allegation set forth in paragraphs 1 through 18.
- 20. Pursuant to Government Code section 54960, any interested person, such as Ms. Farrell Harrison, may "commence an action by mandamus, injunction or declaratory relief for the purpose of stopping or preventing violations or threatened violations" of the Brown Act, or to "determine the applicability" of the Brown Act to "actions or threatened future action" of the legislative body. Similarly, Government Code section 54960.1 allows any interested person, such as Ms. Farrell Harrison, to "commence an action by mandamus or injunction for the purpose of obtaining a judicial determination that an action taken by a legislative body of a local agency" violated the Brown Act and is "null and void."
- 21. The City also violated Government Code sections 54954.2 and 54954.5 at the City Council meeting on April 15, 2025, when certain Councilmembers discussed the agendizing of a

future performance evaluation of the City Manager during the agendized "Potential Litigation" item about her formal complaint regarding the Mayor's potential unlawful activity. The Minutes of this Council meeting confirm that "Potential Litigation" was the only item discussed that evening, and all other items were pushed to the subsequent meeting.

22. Further, the City Council's meeting agenda for the May 6, 2025, City Council meeting failed to comply with Government Code section 54954.5 pertaining to Closed Session item descriptions. Agenda Item 8 for the May 6, 2025, City Council meeting stated:

> PUBLIC EMPLOYEE PERFORMANCE EVALUATION Pursuant to California Government Code Section 54957, (b)(1) Title: City Manager

(See Exhibit B, City of Costa Mesa Agenda, May 6, 2025.) Item 8 on the Agenda listed only "public employee performance evaluation" and did not state "public employee discipline/dismissal/release." (See Gov. Code §§ 54954.5(e) and 54957(b)(1).) The public record disclosed that the matter of the dismissal or termination of the City Manager, Ms. Farrell Harrison, was considered and decided during the Closed Session of the May 6, 2025, City Council meeting. Accordingly, the City did not comply with the Brown Act's agenda-description requirements.

- 23. The City's failure to properly notice its intent to discuss the dismissal or termination of the City Manager violates a core principle as well as the specific requirements of the Brown Act. By failing to describe the dismissal using the language enumerated in Government Code section 54954.5, the City Council violated the Brown Act's rules regarding descriptions of Closed Session items.
- 24. Further, the City's notice of the "Performance Review" of the City Manager was part of a deliberate intent to deceive Ms. Farrell Harrison, City employees, and members of the public. Ms. Farrell Harrison is informed and believes that the City Council deliberately described the May 6, 2025, Closed Session meeting as a "performance evaluation" rather than a "dismissal" to conceal the fact that certain City Councilmembers had engaged in serial meetings outside of a properly noticed City Council meeting.

- 25. Government Code section 54952.2, subdivision b, provides: "A majority of the members of a legislative body shall not, outside a meeting authorized by this chapter, use a series of communications of any kind, directly or through intermediaries, to discuss, deliberate, or take action on any item of business that is within the subject matter jurisdiction of the legislative body."
- 26. The City Council violated the Brown Act's rules regarding serial meetings conducted outside of and prior to a properly noticed meeting. First, the City Council failed to properly agendize and notice the public employee performance review (of the City Manager) on the April 15, 2025 agenda and discussed it under the separate urgent "Potential Litigation" item, the only item discussed that evening. This was deceiving and unlawful because it was not properly agendized. Second, in advance of the May 6, 2025 meeting, Councilmember Buley directed that outside counsel be engaged to attend and advise at the May 6, 2025 meeting pertaining to Ms. Farrell Harrison. If indeed it was a legitimate performance review, it would not necessitate the need for an outside third party attorney. Third, on May 6, 2025, just before the Closed Session meeting started Councilmember Gameros told a local union president, "[Y]ou watch, we're going to switch this whole thing around – instead of this being about the Mayor, we are going to make it about Lori Ann." Ms. Farrell Harrison is informed and believes that Councilmember Gameros and other Councilmembers, including the Mayor, were engaging in serial meetings, in violation of the Brown Act, by deliberating on Ms. Farrell Harrison's termination prior to the noticed meeting.
- 27. The City Council's refusal to "cure or correct" the Brown Act violations referenced supra and noted in Ms. Farrell Harrison's June 5, 2025 letter provide her with the right to file the present lawsuit against Respondent.

#### PRAYER FOR RELIEF

WHEREFORE, Ms. Farrell Harrison prays as follows:

1. That the Court enter a declaratory judgment pursuant to Government Code sections 54952.2, 54954.5, 54960, and/or 54960.1 that the City Council violated the Brown Act by: (1) engaging in a series of communications with the majority of the members of the City

Council regarding Ms. Farrell Harrison's termination outside of a properly noticed City Council meeting; and (2) failing to properly notice the meeting as a "dismissal," instead of a "performance evaluation," and (3) discussing a plan to conduct the City Manager's performance evaluation on April 15, 2025 under the "Potential Litigation" item that had been requested by Councilmember Marr to address allegations of wrongdoing by Mayor Stephens, which is a violation of the Brown Act.

- 2. That the Court issue a peremptory writ of mandate pursuant to Government Code sections 54952.2, 54954.5, 54960, and/or 54960.1 ordering the City Council to:
- Set aside and nullify its action terminating Ms. Farrell Harrison's A. employment with the City on May 6, 2025;
- Alternatively, if the Court does not immediately nullify its action B. terminating Ms. Farrell Harrison's employment with the City on May 6, 2025, produce to Ms. Farrell Harrison and/or the Court all documents, reports, minutes, emails, texts, and phone logs for Closed Session or other closed meetings and discussions and communications related to the Closed Session at which the City Council considered, and agreed upon, its action terminating Ms. Farrell Harrison's employment with the City on May 6, 2025;
- C. Alternatively, if the Court does not immediately nullify its action terminating Ms. Farrell Harrison's employment with the City on May 6, 2025, order the City and the City Council to produce for *in-camera* review all such documents, reports, minutes, emails, texts, and phone logs for Closed Session or other closed meetings and discussions and communications, to allow the Court to determine whether the City Council acted properly in its actions related to Ms. Farrell Harrison;
- D. Record with videotape and audiotape all Closed Sessions pursuant to Government Code section 54960 for three years following entry of judgment in this matter, and maintain those recordings according to law;
- 3. That the Court award Ms. Farrell Harrison reasonable attorney's fees and costs pursuant to Government Code section 54960.5 or, in the alternative, pursuant to Code of Civil Procedure section 1021.5.

4.	That the Court award Ms. Farrell Harrison such other and further relief as the
Court deems j	ust and proper.

- 2. Approved "Alternative 2" of deferred projects (PowerPoint Presentation, page 9).
- 3. Approved reinstating the funding over a 5-year period to ensure a fiscally sustainable General Fund budget.
- 4. Directed staff to bring forth creative options for 2025-26 budget to include repealing or amending CAN, using reserves, cutting contracts including consultant contracts, eliminating vacant positions, and any other additional CIP's to consider deferring.
- 5. Directed staff to bring forth options for council to consider on whether to restore the 2.5% allocation to the Golf Course Fund (which was cut in 2009) which would total 5% to the Golf Course Improvement Fund.
- 6. Directed staff to review fees at the Tennis Center.
